### Crime

The crime rate is a measure of the occurrence of index crimes committed per 100,000 population during a specific period of time. Index crimes include murder, forcible sex offenses, robbery, aggravated assault, burglary, larceny, and motor vehicle theft. The crime rate does not include drug offenses.

The violent crime rate is a measure of the occurrence of violent crimes committed per 100,000 population during a specific period of time. Violent crimes include murder, forcible sex offenses, robbery, and aggravated assault. The crime rate does not include drug offenses.

### Felony Filings

Filings correspond to each defendant against whom an information or indictment is filed. Offenses are categorized in one of four categories, serious crimes against persons (which include capital and non-capital murder cases and sexual offenses), less serious crimes against persons (which include robbery and other crimes against persons), crimes against property (which include burglary, theft, forgery, fraud, worthless checks, other crimes against property, and other non-drug offenses), and drug offenses.

Charges are defined as the individual offenses for which a defendant is accused.

A complaint is a formal written document submitted to the court by a law enforcement officer, prosecutor, or other person, alleging that a specified juvenile has committed a specific delinquent act and requests prosecution of said juvenile

Direct files to felony criminal division

A direct file to the criminal division refers to a juvenile who has been transferred to criminal court for prosecution as an adult following the filing of an information by the state attorney pursuant to section 985.227, Florida Statutes.

### New Commitments to Prison

**Prepared by Florida Legislature, Office of Economic and Demographic Research from monthly datafile provided by Florida Department of Corrections, Bureau of Research and Data Analysis.**

Data were adjusted to account for new commitments which were not included on the monthly data file (which is run on the last day of each month.) The file contains information on approximately 92% of new commitments.

New commitments to prison include offenders with new sentences, violators of control release with new sentences and violators of conditional release with new sentences. Probation violators who have their supervision sentence revoked are also sentenced as new commitments and are included in these numbers.

For purposes of calculating mean sentence length, all sentences longer than 50 years in length are recoded to 50 years (including life and death sentences).
