2/10/2020	CS/SB 1286 (Passed as CS/CS/SB 1286)	<b>Contraband in Specified Facilities:</b> Prohibits the introduction of certain cannabis related substances, cellular telephones and other portable communication devices, and vapor-generating electronic devices inside the secure perimeter of specified facilities of the DCF or of the APD; provides criminal penalties; prohibits the introduction of certain cannabis related substances and vapor-generating electronic devices inside the secure perimeter of a correctional institution, etc. Effective Date: October 1, 2020	+ indet	+ indet	+ indet	+ indet	+ indet	YES
2/10/2020	CS/HB 1287 (Passed as CS/CS/SB 698)	<b>Reproductive Medicine:</b> Provides that certain health care profession licensees & physicians who perform specified acts with human reproductive material without recipient's consent are subject to certain disciplinary action; prohibits health care practitioner from intentionally performing specified acts with reproductive material of donor without recipient's consent; provides penalties; tolls applicable time limitations for criminal prosecution.
