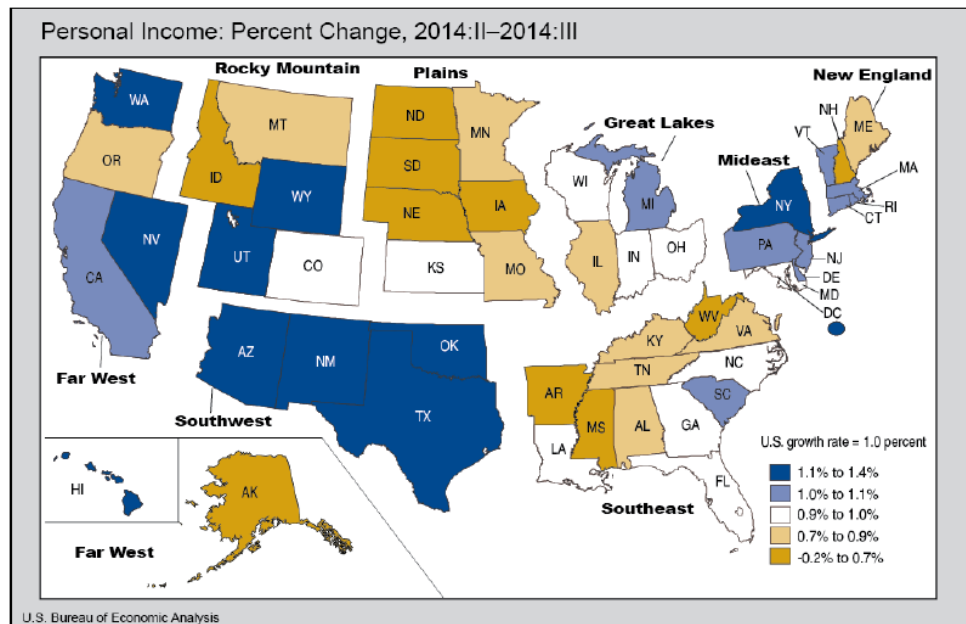


Florida Economic Estimating Conference February 20, 2015

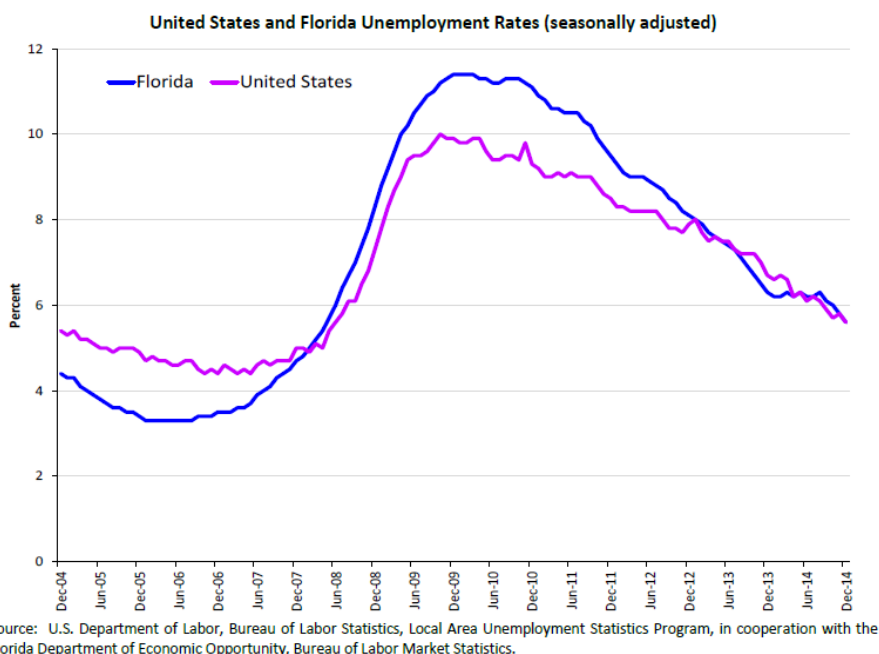
The Florida Economic Estimating Conference met on February 20, 2015 to revise the forecast for the state's economy. The latest forecast reveals an economy that is growing at a slow to moderate pace. The forecast suggests overall stability for the Florida economy, with growth in all of the key economic indicators—personal income, employment, housing starts, light vehicle registrations and visitors. Population growth and continually improving economic conditions yield a forecast that is mostly positive over the entire forecast period.

One of the main factors to measure the economic health of an individual state is personal income growth. Using the latest revised series, Florida personal income growth in the third quarter of 2014 was 0.9 percent over second quarter of 2014, ranking Florida 21st in the country among all states with a growth rate slightly lower than the national average for that quarter. The forecast expects personal income growth to continue with growth rates over the long term ranging between 4.5 percent and 5.8 percent.



Two key measures of employment are job growth and the unemployment rate. The job market in Florida continues to grow at modest rates, with nonfarm employment growth for the last quarter of calendar year 2014 up 2.9 percent over the same period last year. The forecast expects total non-farm employment to exceed the prior peak level by Fiscal Year 2015-16, with modest rates of growth throughout the long run.

With job growth and increased reasons for optimism in the labor market, both the labor force participation rate and the state's unemployment rate continue to improve. The state's unemployment rate in December matched the nation as a whole at 5.6 percent, with 543,000 jobless persons. The rate was as low as 3.3 percent from January through August 2007 (the lowest unemployment rate in more than thirty years, before peaking at 11.4 percent from December 2009 through March 2010.) Florida's unemployment rate has been less than or equal to the national rate for 17 of the last 21 months. The forecast expects the downward trend to continue towards a long-term rate of unemployment around 4.9 percent.



Overall, the housing market continues to trudge forward, but at an uneven pace. For the third quarter of 2014, single-family building permits were 2.4 percent higher than the same period last year and multi-family building permits were 55.7 percent higher than the same period last year. Despite this growth, total private housing starts are still well below the peak Fiscal Year 2004-2005 level of 272,000 units. Total construction expenditures (including residential and public) continue to grow throughout the entire forecast period, with 18.8 percent growth in Fiscal Year 2015-16 and around 5.0 percent growth over the long run. With a slow and steady recovery and foreclosures still affecting the marketplace, housing starts do not recover to their previous peak level at any time during the ten-year forecast period. Total construction expenditures return to peak levels by Fiscal Year 2022-23.

On an even more positive trend, single-family home sales and median prices are growing more than expected, with double-digit growth in single-family home sales during the fourth quarter of 2014 over the same period last year. The Federal Housing Finance Agency price index for Florida has increased to about 69.6 percent of the peak home price index reached in 2006. Single-family home sales return to their peak level by Fiscal Year 2015-16, but median sales prices never regain their peak during the ten-year forecast.

New light vehicle registrations have been a source of strength in the Florida economic forecast. New light vehicle sales for the fourth quarter of 2014 were up 12.4 percent over the same period last year. The forecast predicts a slowdown in this measure as consumers replace their older vehicles and interest rates increase. After stronger than anticipated growth in Fiscal Year 2014-15, the forecast predicts modest growth for the remaining years of the ten-year period.

Florida tourism is a major component of the state's economy. Preliminary estimates indicate that 97.3 million visitors came to Florida during calendar year 2014. For the twelve-month period, preliminary estimates indicate Florida observed a 3.9 percent increase in visitors, compared to 2013. The forecast for Florida visitors continues this trend, with an expected growth in total visitors between 3.8 percent 4.9 percent annually over the next 10 years. The forecast anticipates Florida will reach 100,000,000 visitors by Fiscal Year 2015-2016.
