- (1) The actual amount of the credit will be determined annually by the General Appropriations Act.
- (2) Failure to pass this bill would result in a loss to GR and a gain to trust funds of \$5.7 million in 2001-02 and \$7.7 million for 2002-03.
- (3) In addition to the impacts shown above, this bill would result in a loss to women's athletics of \$80,000 in 2001-02 and \$100,000 in 2002-03.
- (4) The potential statewide impact is -\$4.5 million.
- (5) The conference estimates that if this amendment were approved and implemented by general law, it would cost \$13.9 million statewide
- (6) The numbers included in the attached document are based on information received to date. Information is still being received. The numbers may be revised based on additional information.
- (7) Requires passage of a constitutional amendment.
- (8) Assumes that the PCB is amended to limit the application of the exemption to only transfers between husband and wife.
- (9) This bill would shift \$920,000 from Dade County to various municipalities within the county.
- (10) Moving the issuance of drivers' licenses to the county tax collectors will result in reduced costs of \$8.4 million GR, and \$28.9 million trust
- (11) The potential statewide impact is -\$25.8 million.
