Education Estimating Conference on Student Financial Aid EXECUTIVE SUMMARY March 5, 2014

The Student Financial Aid (SFA) Estimating Conference met on March 5, 2014, to adopt updated student financial aid program estimates for FY 2013-14 and FY 2014-15.

For the Florida Bright Futures Scholarship Program, the FY 2013-14 consensus estimate for total awards is 154,160—an increase of 700 awards (0.5%) from the November 2013 estimate of 153,460 awards. The FY 2014-15 consensus estimate for total awards is 127,573—an increase of 257 awards (0.2%) from the previous forecast of 127,316 awards. FY 2013-14 is the second year of the implementation of increased test score requirements for students to qualify for Bright Futures Scholarships. Scores increase again in FY 2014-15 and remain level thereafter.

Estimates of student counts for FY 2013-14 and FY 2014-15 were also adopted for the William L. Boyd, IV, Florida Resident Access Grant (FRAG) program, the Access to Better Learning and Education (ABLE) program, the various Florida Student Assistance Grant (FSAG) programs, and the Children and Spouses of Deceased or Disabled Veterans (CSDDV) program. The adopted student counts are shown on the Consensus Summary.

FY 2013-14 student count estimates for all programs were adopted as presented by the Office of Student Financial Assistance (OSFA). For FY 2014-15, the Conference adopted OSFA's estimates for the ABLE and CSDDV programs. For the FRAG program, the Conference adopted an estimate of 37,453 awards, a 1.2% increase over the FY 13-14 estimate. For the FSAG programs, the Conference adopted an estimate of 214,802 awards (includes 124,103 current year awards + 84,824 otherwise eligible students + 5,875 students previously funded with College Access Challenge Grant funds).

Across all programs, the Conference anticipates 319,866 awards in FY 2013-14 and 384,484 potential awards in FY 2014-15. More details for each program can be found in the Consensus Detail.



Sections 216.134(4) F.S., Consensus Estimating Conferences and 216.136(4) F.S., Education Estimating Conference:

Principals include professional staff designated by the coordinator of the Office of Economic and Demographic Research, the Executive Office of the Governor, the Senate, and the House of Representatives. Responsibility for presiding over sessions of the conference rotates among the principals.

Duties include the development of the number of students qualified for designated state financial aid programs, the William L. Boyd, IV, Florida Resident Access Grant and Access to Better Learning and Education programs, and the appropriation required to fund the full award amounts for each program.

- Florida Bright Futures Scholarship Program (BF)

Florida Bright Futures Scholarship Program

(Attachment A)

2013-14

- The 2013-14 appropriation is \$309,413,826 to award 152,164 students; the March 2013 consensus of estimated eligible students.
- The March 2014 projection for the 2013-14 cost is approximately \$306.2 million which is about \$3.25 million less than the appropriation, with a student count of 152,945.

The Term 2 expenditures needed at the beginning of Term 2 to cover the cost of courses subsequently dropped or withdrawn by the end of Term 2 is \$2.49 million.

Assumptions for the 2013-14 projections:

- The student counts across sector and program are from 2013-14 Term 1 actual students projected to an End-of-Year total.
- For initial recipients, the average credit hours disbursed, across sector and program, are from 2013-14 Term 1 actual students projected to an End-of-Year total.
- For renewal students, we used the 2012-13 actual End-of-Year disbursed hours of students (after students drop or withdraw from classes).
- Cost projections are based on the actual 2013-14 flat award amount per credit hour.

2014-15

- The November 2013 projection for the 2014-15 cost was \$258.3 million with a total student count of 127,181.
- The March 2014 projection for the 2014-15 cost is \$256.4 million, with a student count of 125,878.

An additional \$2.08 million is needed at the beginning of Term 2 for course hours that students will thereafter drop or withdraw, for which institutions are not required to refund until after the end of the term.

Assumptions for 2014-15 projections:

The 2013-14 high school graduating class is required to earn a 1290 SAT rather than a 1280 score to qualify for an initial Florida Academic Scholars (FAS) award, and earn an 1170 SAT rather than a 1020 score to qualify for an initial Florida Medallion Scholars (FMS) award.

Initial Students

- The initial student counts across sector and program are based on the disbursed students from the 2013-14 Term 1 file who met the higher test score requirements, and then projected to an End-of-Year total. The total was used to calculate the percentage of 2012-13 standard high school graduates who earned the higher test scores. The resulting percentage was applied to the estimated number of standard high school graduates for the 2013-14 school year in determining the number of initial students.
- The average credit hours disbursed, across sector and program, are from 2013-14 Term 1 actual students who met the higher test scores projected to an End-of-Year total.

Renewal Students

- The renewal disbursed student counts across sector and program are based on historical renewal rates.
- We used the 2012-13 actual End-of-Year disbursed hours of students (after students drop or withdraw from classes).

Cost projections for both initial and renewal students are based on the actual 2013-14 flat award amount per credit hour.

William L. Boyd, IV, Florida Resident Access Grant

2013-14

- The 2013-14 appropriation is \$89,664,961 for 36,568 students.
 - 32,477 students at \$2,500 per annual award for FRAG eligible institutions that participated prior to 2011-12
 - 4,091 students at \$2,071 per annual award for the newly eligible participating institutions, Keiser University and The Baptist College of Florida.
- The March 2014 projection for End-of-Year full-time equivalent (FTE) students increased to 37,008 based on an increased number of students being funded.
- Term 2 awards were prorated for institutions that participated prior to 2011-12 from \$2,500 to \$2,467 based on Term 2 remaining balance and number of students institutions reported as requiring funding.
- We expect to fully expend the program funds to eligible students.

2014-15

- The 2014-15 LBR was \$89,851,351 for 36,658 FTE students.
- March 2014 projection for 2014-15 reflects a growth from the projected 2013-14 Endof-Year FTE student count to 38,337, recommended for consensus.
- The projected cost is based on the 2013-14 award by institutions as above and increases to \$95,842,500, an increase of \$6M.
- The maximum award is set in the General Appropriations Act each year.

Access to Better Learning and Education

(Attachment C)

2013-14

- The 2013-14 appropriation is \$3,239,567 for 2,789 FTE students to each receive a maximum award of \$1,161.
- The March 2014 projection of End-of-Year student FTE increased to 3,793 due to four newly eligible institutions participating in the program and an increase in the number of students being funded in the program. Term 2 awards were prorated from \$1,161 to \$854 based on Term 2 remaining balance and number of students' institutions reported as requiring funding for their students.

2014-15

- The 2014-15 LBR was \$3,649,400 for 3,143 FTE.
- The March 2014 projection for 2014-15 End-of-Year FTE student count is 3,793 recommended for consensus.
- The maximum award is set in the General Appropriations Act each year.

2013-14

- The 2013-14 appropriation is \$133,596,977.
- The March 2014 projection for End-of-Year students is 124,103.
- The 2013-14 projected combined average state award for the three degree seeking need grant programs (Public, Private, Postsecondary) is \$1,096, or 42% of the maximum award.
- The state appropriation of \$133 million is projected to be expended within all four grants; Public, Private, Postsecondary and Career Education.
- An additional \$990,273 of federal matching funds will also be expended.

2014-15

- The 2014-15 LBR was \$133,596,977 to fund 162,278 students.
- The March 2014 projection for 2014-15 student count is 224,598, which includes Otherwise Eligible students (those who meet FSAG requirements but do not receive an award due to funding constraints), recommended for consensus.
- The maximum award is set in the General Appropriations Act each year.

Children/Spouses of Deceased or Disabled Veterans (Attachment E)

2013-14

- The 2013-14 appropriation was \$2,895,907 to fund 802 students.
- The November 2013 projected cost for 2013-14 was \$2,889,606 to fund 802 students at an average award of \$3,603.

2014-15

The March 2014 projected cost for 2014-15 is \$3,156,030. This is based on a 1.5% rate of inflation, resulting in an average award of \$3,657 that would fund 863 students.
