The Voluntary Prekindergarten Estimating Conference adopted forecasted fiscal year enrollments and full-time equivalent (FTE) enrollment for the Voluntary Prekindergarten Program (VPK) for 2009-10, 2010-11, 2011-12 and 2012-13. The enrollment and FTEs for 2008-09 were revised for actual data through the end of school year and for actual summer data reported through June 30, 2009.

The revised fiscal year enrollments and FTEs are as follows:

Updated data used for the revised estimates and forecasts are:

1. 2008-09 school year data through June 2009 (actual except for reconciliations),
2. Preliminary 2008-09 summer data for May 2009 and June 2009, and
3. Updated estimates of the Florida population of children aged four.

The 2008-09 program year enrollment estimate is slightly higher than expected. About 63.18% of eligible four year olds are expected to participate in the 2008-09 program compared with

58.25% in the 2007-08 program. It is anticipated that about 70% of the eligible four year olds will be participating by the 2011-12 program year.

The FY 2008-09 enrollment, which is actual except for small updates and reconciliations, is slightly higher than expected for both the school year and the May-June 2009 summer program. The FY 2008-09 FTEs are higher due to slightly higher enrollment and higher number of hours attended than expected.

The assumptions for the 2009-10 through 2012-13 forecasts are:

1. The uniform attendance policy due to begin implementation in the 2009-10 program year will have an insignificant impact upon FTE.
2. By 2011-12, 70% of the eligible four year olds will be participating in the program. The program will continue at the 70% participation level.
3. Enrollment in the summer program has stabilized and is expected to remain around 9,600 enrollment throughout the forecast time period.
4. Attendance in the program will continue to increase during the time period which will increase the ratio of the FTE to enrollment.

VPK Uniform Attendance Policy

Florida Statute 1002.71(6):

(d) The Agency for Workforce Innovation shall adopt, for funding purposes, a uniform attendance policy for the Voluntary Prekindergarten Education Program. The attendance policy must apply statewide and apply equally to all private prekindergarten providers and public schools. The attendance policy must include at least the following provisions:

1. Beginning with the 2009-2010 fiscal year for school-year programs, a student's attendance may be reported on a pro rata basis as a fractional part of a full-time equivalent student.
2. At a maximum, 20 percent of the total payment made on behalf of a student to a private prekindergarten provider or a public school may be for hours a student is absent.
3. A private prekindergarten provider or public school may not receive payment for absences that occur before a student's first day of attendance or after a student's last day of attendance.

The uniform attendance policy shall be used only for funding purposes and does not prohibit a private prekindergarten provider or public school from adopting and enforcing its attendance policy under paragraphs (a) and (c).

Overview of the Proposed Rule:

- Coalitions are required to enter child absence data into the Enhanced Field System (EFS).
- Providers will no longer be required to obtain or keep "mommy notes" to document a child's absence.
- The 80-20 formula will be calculated within EFS monthly to ensure that a minimum of 80% of a provider's payment for any single child is made for days the child attends the program; a maximum of 20% of the provider's payment per student can be for days the child is absent.
- If a child is absent for more than 20% of the time in a given month, the provider will not receive payment for absences beyond the allowed 20%.
- A child could exceed 20% for a given month but not exceed 20% for the entire program.
- A final reconciliation will take place at the end of the program to determine if a child exceeded 20% for the entire program. This formula **may** result in additional funds being due to a provider after the program concludes.
- A provider will not receive payment for absences that occur prior to the child's first day of attendance or after its last.
- A private provider or school district may not receive payment for a student prior to the student's first day of attendance or after a student's last day of attendance.





