⁽B) The revenue estimate has been adjusted for the impact of the Supreme Court ruling on the unconstitutionality of the \$295 motor vehicle impact fee. The state is liable for refunds in the amount of \$187.2 million. In addition, \$50.8 million in FY 1994-95 and \$66.9 million in FY 1995-96 of revenues previously expected to be collected have been eliminated from the revenue estimate.
