(A) The funds available figures are not adjusted for any financial obligation related to the constitutional funding requirement for tobacco education and prevention. The amount of the financial obligation is estimated to be \$83.7 million for FY 2023-24; \$86.5 million for FY 2024-25; \$88.2 million for FY 2025-26; \$89.8 million for FY 2026-27; and \$91.8 million for FY 2027-28.
