

**Public Schools PreK-12 Education Estimating Conference**  
**Executive Summary**  
**April 15, 2013**

The Public Schools PreK-12 Education Estimating Conference met on April 15, 2013 to review school district forecasts of FTE student enrollment for 2013-14 and to adopt forecasts for 2013-14 through 2016-17. The previous conference that adopted FTE enrollment forecasts was held in February 2013.

***Key Assumptions***

- Continuation of recent historical patterns --- The most recent growth patterns are expected to continue, with the exception of virtual education, which will reflect the new graduation requirement for high school graduates to complete an online course starting with students that entered grade 9 in 2011-12.
- Effects of 2011 and 2012 legislation --- Recent legislation has the potential to affect the FTE enrollment levels. Changes affecting charter schools and virtual education may increase the FTE enrollment and changes affecting the tax credit scholarship program may decrease the FTE enrollment.

***Analysis and Trends***

- 2013-14 Forecast --- The 2013-14 forecast differed from the February 2013 forecast by 1,448.60, representing gains in all grades. At the February 2013 conference, District forecasts reflected current law in regards to program sort order for the calculation of funded FTE. This resulted in a decline in reported career education and an increase in reported basic education for funding purposes when compared to prior years. The conference met in early March to look at the current law impact on the FTE sort order. The principals agreed that the April forecast should reflect unweighted FTE based on program sort order that would be similar to practices in years prior to Fiscal Year 2012-13. Also, the 2013-14 forecast for the Florida Virtual School reflects the new graduation requirement for high school graduates.
- Career Education --- The 2012-13 fourth calculation FTE enrollments show a decline in funded FTE for career education, reflecting reporting changes that came out of the 2012 Legislative Session.
- Virtual Education --- The 2011 Legislature added a full-time K-12 Florida Virtual School (FLVS) program and the 2012 Legislature expanded the eligibility for the full-time and part-time FLVS programs. Both part-time and full-time programs at the Florida Virtual School are expected to grow during the forecast time period, with most of the growth occurring from the part-time program including Virtual Learning Laboratories. Some of the expected growth in the full-time program is expected to come from students entering from private and home-schooled education. There is also an expected increase in virtual education in the remaining 74 districts; however this will not result in an increase in FTE.
- Charter Schools --- New charter schools will continue to attract students to public education. The growth due to new charter schools is expected to increase as high performing charter schools are allowed more flexibility for expansion and replication. Although most of the students enrolled in the new charter schools will have previously been enrolled in a traditional public school, there is expected to be some students in private and home-schooled education attracted to the new charter schools.
- Tax Credit Scholarship Program --- The 2012 Legislature increased the tax credit cap for this program. The higher cap will allow additional tax credit scholarships to be provided. Thus, this change has a potential to decrease the public school FTE enrollment.

Tables 1-3 have comparisons of the forecast with previous years and with the February 14, 2013 forecast.

### **General Notes**

The Education Estimating Conference for Public School Enrollment forecasts full-time equivalent (FTE) students whose educational instruction is funded through the Florida Education Finance Program (FEFP). There are ten program categories in two groups:

#### Group 1

- Three for basic education students who are not exceptional education students (101: for PK through Grade 3; 102: for Grades 4 through 8; 103: for Grades 9 through 12) and
- Three for basic education exceptional educational students by grade grouping (111, 112, and 113).

#### Group 2

- One for English Language Learners (130),
- Two for exceptional education students who need higher levels of services (254, 255) and
- One for students taking career education instruction (300).

The funded educational time for a student may be in a single program category or spread through two or more program categories.

The FEFP is calculated five times throughout the year to arrive at each year's final appropriation. Each calculation ("calc") uses the latest information regarding the number of students that is available:

- (1) First Calculation – This calculation is completed immediately after the annual legislative session. Student counts are based on the forecast made for the Legislature.
- (2) Second Calculation – This calculation is made upon receipt of the certified tax roll from the Department of Revenue. Student counts are based on the forecast made for the Legislature.
- (3) Third Calculation – This calculation includes the October survey, July actual, and February estimate. It is made upon receipt of districts' October survey FTE reported in November and estimated June FTE reported in November.
- (4) Fourth Calculation – This calculation is made upon receipt of districts' February FTE and estimated June FTE reported in March.
- (5) Final Calculation – This calculation is made upon receipt of districts' June FTE reported in September or October.

'PK' figures include only pre-school age children with disabilities (ESE) and pre-school age children whose parents are in the Teenage Parent Program. It does not include children participating exclusively in the Voluntary Prekindergarten Program who receive those services through the public school system.

## **Status of Fulfilling the Online Course Graduation Requirement for the First Group of Students with the Requirement**

Beginning in the 2011-12 school year, students who enter grade nine must successfully complete an online course to receive a standard diploma. A survey of 16 school districts was conducted to assess the status of fulfilling this requirement for students who entered grade 9 in 2011-12 and are the first group of students with the online course graduation requirement.

### Survey Districts

The sixteen school districts were selected for the survey as follows: The ten largest districts (L) and two districts chosen randomly from each of the following three strata: medium (M), small-medium (S-M), and small (S). The districts selected were Brevard (L), Broward (L), Columbia (S-M), Miami-Dade (L), Duval (L), Gilchrist (S), Hardee (S), Hillsborough (L), Lee (L), Marion (M), Orange (L), Palm Beach (L), Pinellas (L), Polk (L), Putnam (S-M), and Volusia (M). The results were extrapolated to the remaining districts and the state summary is detailed below.

### 2012-13 School Year

For the 2012-13 school year, there are estimated to be 195,969 students in this cohort who are seeking a standard diploma. Of these students:

- 29.8 percent (58,430) are expected to have met the requirement by the end of the school year and
- 70.2 percent (137,539) will not have met the requirement for an online course.

### 2013-14 School Year

- It is expected that there will be a net decrease of 10,118 students for the group of students who still need to meet this requirement between the 2012-13 and 2013-14 school years. This net change is due to students leaving (move out of the state, enter private education, enter home education, drop out of school, etc.) and students entering (move in from other states or countries, enter from private school and home education, etc.).
- The net loss of 10,118 students means there will be 127,421 students remaining at the beginning of 2013-14 who need to fulfill the requirement. Of these students:
  - 57,893 are expected to fulfill the requirement in 2013-14, and
  - 69,528 are remaining to fulfill the requirement.

### 2014-15 School Year

- It is expected that of the 69,528 students who still need to meet the requirement at the end of the 2013-14 school year:
  - 8,867 will leave the Florida K-12 public education system before the beginning of the 2014-15 school year and
  - the remaining 60,661 students will fulfill the requirement in 2014-15.

## Summary

- The number of students who are expected to meet this online graduation requirement after 2012-13 is 118,554 students (57,893 in 2013-14; 60,661 in 2014-15).
- These 118,554 students are expected to generate 12,655.88 full-time equivalent (FTE) students in virtual options in order to meet the online graduation requirement.
