#### Impact of 2009 Legislation on Full Time Equivalent (FTE) Student Enrollment

Some bills enacted during the 2009 Legislative Session include policies and provisions that will impact FTE student enrollment for Pre-K-12 programs. Bills that may have an impact on enrollment are discussed below.

# 1. HB 453 (Chapter 2009-108, L.O.F.) – Section 220.186, F.S. TAX CREDITS FOR SCHOLARSHIPS TO NONPROFIT SCHOLARSHIP-FUNDING ORGANIZATIONS

The Corporate Income Tax Credit Scholarship has been renamed as the Florida Tax Credit Scholarship Program (FTCS).

Insurance corporations may now receive a credit against the insurance premium tax if they contribute to the FTCS Program. Previously corporations were limited to receiving credits from the corporate income tax.

Students on the Direct Certification List may now participate in the FTCS Program. School districts are now required to notify households receiving free or reduced-price meals of their eligibility to apply for the FTCS.

# 2. HB 991 (Chapter 2009-144, L.O.F.) — Section 1001.42, F.S. FLORIDA'S EQUAL OPPORTUNITY IN EDUCATION ACT

The Department of Education will establish criteria for determining low-performing schools, categorize schools based on grades and rate of improvement, and provide interventions and support strategies to the low-performing schools.

This bill requires, among other things, that the school district submit plans to the Department of Education to improve performance of low-performing schools and that low-performing schools make significant progress by improving their grade and increasing student performance in mathematics and reading.

### 3. SB 1676 (Chapter 2009 – 59, L.O.F.) — Education Funding Conforming Bill VIRTUAL SCHOOL PROGRAMS

Section 10: The Florida Virtual School (FLVS) shall not receive funding through the FEFP for class size reduction.

Section 29: The FLVS supplement of 0.114 is limited to students who also attend a district public school. The Florida Virtual School may not claim the supplement for private, Home Education, or other non-public school students.

Section 11: High school students registered in dropout prevention, academic intervention, or Department of Juvenile Justice (DJJ) education programs may enroll in full-time or part-time courses offered by the District Virtual School.

# 6. SB 1128 (Chapter 2009 – 35, L.O.F.) — Section 1003.57, F.S. EDUCATION/CHILDREN IN SHELTER CARE OR FOSTER CARE

Deals with students placed in a residential health care facility in a different school district. The receiving school district is to be notified within 10 days of this placement. The receiving school district is then required to review the student's Individual Education Plan (IEP) and notify the sending school district as to whether the receiving district can implement that student's IEP.
