Education Estimating Conference on Florida College System Enrollment Executive Summary December 7, 2020

The Education Estimating Conference on Florida College System Enrollment met on December 7, 2020 to review and adopt a new forecast for Florida College System full-time equivalent (FTE) enrollment. The estimates are based on preliminary FY 2020-21 Term 1 enrollment data, the Division of Florida Colleges' enrollment projection model based on that data, and adjustments to the model provided by the colleges.

Overall, estimates for FY 2020-21 reflect the impact of the Coronavirus outbreak on college operations, as well as the persistent pandemic-induced economic contraction. In particular, the shape of the forecast is colored by the reinstatement of historic patterns of increasing enrollment when the unemployment rate is high, once the immediate threat of the pandemic is ameliorated by the widespread distribution of an effective vaccine.

The Division of Florida Colleges FTE-1 estimate was 302,205.0 FTE for FY 2020-21. After taking into account adjustments submitted by the colleges, the FTE-1A estimate is 301,948.0, a decrease of 257.0 FTE (-0.1%) below FTE-1. The Conference adopted the FTE-1A estimate by college for FY 2020-21 as presented.

This adopted FTE-1A estimate is lower than the August projection by 10,432.0 FTE (-3.3%). Compared to prior year enrollment, the FTE-1A estimate reflects a decrease of 14,327.9 FTE (-4.5%). Additionally, three colleges are expecting increases in enrollment, twenty-four colleges are anticipating declines in enrollment, and one college is expecting enrollment to be unchanged over the prior year.

For all Lower Division programs, FTE enrollment is expected to decrease by 15,797.9 FTE (-5.3%) compared to the prior year. The most significant enrollment decline is anticipated to occur in the Advanced and Professional program, by 9,117.0 FTE (-4.3%) from the prior year. For Upper Division programs, the FTE-1A estimate reflects an increase of 1,470.0 FTE (8.0%) over the prior year. Upper Division FTE is expected to represent approximately 6.6% of total enrollment in FY 2020-21.

The following table shows the adopted FY 2020-21 FTE-1A enrollment compared to the prior year enrollment as well as to the August 2020 estimate.

Going forward, the Conference believes that traditional patterns of increasing enrollment when the unemployment rate is high will come back into play—at least as soon the immediate threat of the pandemic is ameliorated by the widespread distribution of effective vaccines. Since this is expected in early FY 2021-22, it produces an atypically high growth rate of 4.2% for the transition year.

The Conference adopted forecasts by college for FY 2020-21 through FY 2023-24 are shown below.

Justification for accepting the State's projection: EFSC accepts the FLDOE's FTE-1 Enrollment Projections. While actual summer enrollment, which showed an increase from the prior summer by 3.84% with strong increases in bachelor program enrollment during summer and fall (up 30% and 9% respectively), we anticipate a decrease in enrollment this year due to the ongoing pandemic which has caused disruption for many students. Fall enrollment is down considerably, end-of-term fall enrollment is expected to rise after the beginning of term data submission, but this will not make up for the more than 9% loss from last fall to this fall. The Covid-19 pandemic has played a significant part in the decrease in enrollment thas coincided with the pandemic may play a potentially large role in enrollment changes over the next two years. Typically, when unemployment rates increase of about 55% an increase of close to 86% increase in unemployment in Brevard County through 2007-2008 from 4.4% to 6.7% (increase of about 53%) and EFSC saw enrollment for fall jump by about 6%. Currently for both the Spring 2021, the UD category is up by 2.85%. Other Factors - Upper Division: The current estimate exhibits a 14% increase from 2020-21 at 568 to 658 which we do not believe to be representative of the current trend of the college. In looking at the past eight years of FTE-3 data, we can see that FSW Upper Division enrollment has never been below 560, and has never been higher than 640 (see Figure 1 on the next page). Further, the current trend exhibits a stabilization of the enrollment, and shows no significant downward or upward trend. The last four years, for example, have been within an enrollment of the previous year of 20 or less. Further evidence can be seen in Figure 3, "Fall 2020 FTE Comparison 12 Days Until the First Day of Classes." Here, in an enrollment snapshot from 8/10/2020, we can see that while overall FTE is down, the School of Business & Technology, Education, and Health Professions, where all Upper Division programs exist at FSW, are up from the previous year ranging from 0.6% to 21.6%. This is despite the global pandemic which has caused a slight downturn in overall enrollment. We can also see from Figure 2, a snapshot of enrollment on 5/21/2020, that further out before the semester began, the increases shown in the Upper Division were not yet clearly distinguished as enrollment had not yet fully recovered. Business & Technology, for example, climbed from -5.7% to +0.6%. It is for these reasons that we feel that next year is expected to be no different, or with little difference, from previous years, and so we recommend the adjustment from the division estimate of 658 to a more stable 613.	

		Advanced & Professional: The division estimate exhibits a 7% decrease from 9253 to 8671 which we do not believe to be representative of the immediate trend of the college. In looking at the past eight years of FTE-3 data, we can see that FSW Advanced & Professional enrollment has stabilized in recent years after having increased from 8000 eight years ago to approximately 9300 today. Enrollment has not been as low as the division estimate since 2014. It is for this reason that we feel it is expected to be no different, or with little difference, from previous years, and so we recommend the adjustment from 8671 to 8962. Postsecondary Vocational: The division estimate exhibits a slight decrease from 724 to 717 which we do not believe to be representative of the current stability of the data. In looking at the past eight years of FTE-3 data, we can see that Postsecondary Vocational at FSW has been on a steady incline since correcting a nadir four years ago (Figure 1). Since then, enrollment has increased from 231 to stabilize at just over 700, where it has been maintained for the previous three years. It is for this reason that we feel that it is expected to be no different, or with little difference, from previous years, and so we recommend the adjustment from the division estimate of 717 to 721. Dev Ed: The division estimate exhibits a decrease in Dev Ed numbers. The introduction of ENC 1130 as a support measure for those needing additional writing skills enhancement caused an initial drop seen from 2019-20 FTE3 to 2020-21 FTE1 (see documents following Figure 3), but now that the course is in place and pilot phase is over, we expect a stabilization to approximately 211.	
7	Fla SC at Jax	Florida State College at Jacksonville (FSCJ) has reviewed and accepted the Florida College System's FTE-1 Estimates for 2021. FSCJ has been closely monitoring its FTE this fall 2020 semester and acknowledges that our data supports an end of year FTE of 16,313, which represents a total -4.92% decline (not including CWE) over FSCJ's 2019-20 FTE. FSCJ's enrollment decline, as the vast majority of state/community colleges across the country, is of one the lingering effects of COVID- 19. UD – Florida Gateway College will begin offering the Bachelor of Science degree in Elementary Education (K-6) with an emphasis in Science, Technology, Engineering, and Math (STEM) in Spring 2021 (see supporting documentation b.1.a. – website announcing new program). The program was first approved by the Florida Department of Education in November 2019 (see supporting documentation B.1.b – 11-18 KH Letter of Approval). FTE in Fall 2020 fell significantly (approximately 7.5%) from the FTE in Fall 2019. However, strong enrollment in our online summer term offerings has mitigated some of that decline. Based on the early enrollment numbers and level of interest in the Holiday session, this is a very conservative estimate.
Overall, we anticipate that the A&P enrollment will ultimately fall slightly short of the 2019-20 enrollment, but the degree of the reduction will be at a far smaller than the Division's projected FTE for 2020-21.
PSAV – Basic Corrections Certificate: FGC is increasing the estimate for Postsecondary Adult Vocational FTE due to an additional expected class of Basic Corrections students in the Spring 2021 term. The college normally starts 75 to 100 students in this program each year, but have already trained 130 students already this year. The Basic Corrections program is a 420 clock hour program consisting of 12 individual courses. This growth is primarily attributed to a FTE enrollment surge from summer 2019 to summer 2020 of about 18%. Since the pandemic began, Valencia has taken measures to ensure continuity of education. Amongst those measures is the implementation of the R20 grade process which is explained in the attached exhibit A. The net change from the revised 2020-21 FTE 1 estimate to the prior 2020-21 FTE 1 submission results in an immaterial decrease by about 70 FTE which represents less than 0.20% change. 1. New/Improved Program - 2. Program Reduction/Deletion- 3. Opening of New Campus or Center - 4. Policy Decisions - 5. New/Expanded Industry - FTE enrollment in upper division programs is estimated to grow by more than 40% as compared 2019-20 FTE. The incremental growth in 2020-21 estimate is primarily driven by the Business and Management program by about 300 FTE, engineering programs such as Computing Technology and Software Development by 50 FTE, and the continued expansion of the nursing program by 40 FTE. 6. Other Factors - The counter cyclical nature of unemployment and effect of college FTE enrollment caused by the COVID-19 pandemic combined with the college's current efforts to increase retention and focus on returning students delivered a double digit FTE enrollment growth in summer 2020 as compared to prior summer term by nearly 18%. This would result in an estimated aggregate growth for the 2020-21 reporting year by nearly 5%. FTE enrollment in the Advanced & Professional category is estimated to increase by slightly over 1,000 FTE or 5% primarily driven by Social, Physical, and Biological Science disciplines accounting for 6% of the t	Adjusted
