

Florida Economic Estimating Conference

September 9, 2011

The outlook for Florida's economy has been revised downward. This downward revision is primarily attributed to weak construction expenditures and its secondary effects on overall employment and income growth. From a historical perspective, the amount spent on construction coming out of this recession has been far less than the amount spent coming out of previous recessions. Looking at the past three recessions (not counting the most recent), growth in total construction expenditures had risen on average 30.6 percent during the nine quarters following the end of the recession. The largest gain (48 percent) was seen after the end of the 1981-82 recession. In comparison, since the Great Recession, growth over the last nine quarters has decreased -18 percent. To some degree this should come as no surprise as the number of foreclosures continues to dilute monthly sales prices and add more properties to an already bloated supply of homes. Moreover, unemployment remains persistently high, income growth is slowly deteriorating, and banks continue their stringent lending practices.




As a result of this prolonged decrease in construction expenditures, the Conference's outlook for total nonfarm employment has been reduced. For fiscal year 2011-2012, employment is expected to grow

.09 percent. This equates to roughly 64 thousand new jobs; the prior estimate (Feb. 2011) anticipated 129 thousand new jobs. Looking towards fiscal year 2012-13, job growth remains anemic. Employment is expected to increase only 1.4 percent, roughly 101 thousand new jobs. This is 75 thousand less jobs than previously projected. Also, the unemployment rate is expected to remain stubbornly high. It is expected to remain above 10 percent through the 2012-13 fiscal year.

Other areas of the economy are at various stages of recovery. Total vehicle registrations have been revised downward. This follows directly from lower employment and income growth. However, future growth in registrations is expected to be strong as the age of existing vehicles necessitates the need for replacement.

A projected increase in the number of visitors to Florida, at least for the time being, remains the only bright spot in the forecast. As long as the rest of the nation continues to improve, it is expected that the number of visitors to Florida will gradually increase. This bodes well for the State's tourism-related service employers, namely hotel and restaurant establishments.
