

EXECUTIVE SUMMARY
Revenue Estimating Conference for the General Revenue Fund
November 14, 2007

Since the General Revenue Estimating Conference held in early August, the housing market has further deteriorated – pushing business and consumer spending lower. In response, the Revenue Estimating Conference has reduced the General Revenue outlook by \$2.5 billion for Fiscal Years 2007-08 and 2008-09. Collections for Fiscal Year 2007-08 are expected to be below estimate by \$1.0 billion or 3.9% lower than the already-reduced estimate from August. For Fiscal Year 2008-09, expected revenues were decreased by an additional \$1.4 billion or about 5.2% from the earlier forecast.

The new estimate projects revenue collections in Fiscal Year 2007-08 to be less than Fiscal Year 2006-07 receipts by \$932.6 million or 3.5%. This marks the second consecutive year with a decrease from the prior year – final revenue collections for Fiscal Year 2006-07 were 2.4% lower than Fiscal Year 2005-06. The revisions to the forecast are attributable to several factors. First, the expected downturn in the housing market has been exacerbated by the subprime financial shock and tightening credit and lending practices, and is expected to persist longer. Second, Florida's population growth has been slowing, reflecting general economic conditions both nationally and in the state. While the state's economic forecast mirrors the national outlook in many ways, the heightened level of speculative activity and second-home buying in Florida made it particularly vulnerable to the real-estate market slowdown. Third, energy prices reaching record highs reduce disposable spending for household and increase businesses' operating costs. These economic conditions influence revenue collections in the following ways:

- **Sales Tax** collections are weaker as sales attributable to record-level housing construction have been declining. Related spending for items like furniture and appliances has also slowed as existing home sales settled at monthly levels last seen in 1997. Further, Floridians have curtailed other purchases like automobiles as the wealth effect from housing price appreciation diminished and overall consumer spending slowed. Business-related purchases have also been sluggish and are expected to remain lower than previous estimates. These adjustments persist throughout the forecast period.
- **Documentary Stamp and Intangibles Tax** collections are expected to keep falling as housing market and credit conditions worsen. Housing prices will weaken further and collections will not recover until prices stabilize and sales rebound.
- **Corporate Income Tax** collections are expected to lose some of their previous gains before stabilizing. After reaching an historic growth rate of 39.1% in Fiscal Year 2005-06, receipts grew only 1.6% in Fiscal Year 2006-07 and are projected to decline 4.9% in Fiscal Year 2007-08. The revisions are largely due to: (1) weaker profits in companies previously benefiting from the overheated real estate market, (2) corporate adjustments to subprime-related losses, and (3) compressed profit margins caused by rising costs.

While the housing and demographic outlooks have worsened in the short run, more normal growth rates are anticipated to return in 2009. However, estimated revenue collections will not exceed the Fiscal Year 2005-06 level until Fiscal Year 2009-10.

FOOTNOTES

(A) The FY 2007-08 statutory balance in the Budget Stabilization Fund is \$1353.7 million. No transfer is required for FY 2008-09. These figures do not include hurricane-related budget amendments transferring funds to the Casualty Insurance Risk Management TF which must be repaid (EOG #483 for FY 2004-05 of \$11.0 million and EOG #205 for FY 2005-06 of \$11.8 million). At the time of this statement \$11.7 million remains unpaid.

(B) This financial statement is based on current law as it is currently administered. It does not include the potential effect of any legal actions which might affect revenues or appropriations. The Attorney General periodically issues an update on any such litigation. In addition, it does not recognize any deficits in any spending programs unless specifically stated.

(C) Hurricane related expenditures were made through budget amendments which anticipate repayment from FEMA funds.
