

EXECUTIVE SUMMARY

Revenue Estimating Conference for the General Revenue Fund

October 11, 2011

Since the March General Revenue Estimating Conference, revenue sources have displayed mixed results with August as a significant turning point—especially for Sales Tax collections. At the end of the 2010-11 fiscal year, overall collections were \$139.1 million above estimate. In contrast, preliminary results for the first quarter of the current fiscal year indicate a loss from the overall estimate of approximately \$106 million. Further, the pace of the housing and employment recovery has significantly slowed, as reflected in the new economic forecast for Florida. Consequently, the Revenue Estimating Conference has lowered most elements of its near-term forecast. For Fiscal Year 2011-12, expected revenues were decreased by \$599.6 million or 2.5% below the earlier forecast. For Fiscal Year 2012-13, expected revenues were decreased by \$968.3 million or 3.8% below the earlier forecast. As in prior estimates, these forecasts do not specifically identify any losses related to the Deepwater Horizon oil spill.

Today's revised FY 2011-12 revenue estimate is \$643.9 million or about 2.9% above actual collections for FY 2010-11. The FY 2012-13 forecast remains positive with projected growth of 5.7% over the revised FY 2011-12 estimate.

Overall, the adjustments to the forecast indicate an economy that is still in the throes of an abnormally slow recovery. While year-over-year growth is expected, the rates have been reduced and some of the originally anticipated growth removed. Revenue estimates are primarily affected in the following ways:

- **Sales Tax...** This fiscal year, Sales Tax collections were adjusted downward in all categories except Consumer Nondurables and Tourism & Recreation, which were essentially held to the current estimate. For next year, the growth in Sales Tax collections was lowered from the March forecast in every category. For General Revenue, the forecast was lowered by \$267.1 million in FY 2011-12 and by \$742.8 million in FY 2012-13.
- **Documentary and Intangibles Taxes...** Collectively, anticipated General Revenue Fund receipts from Documentary and Intangibles Taxes were decreased by \$79.8 million in FY 2011-12 and \$150.3 million in FY 2012-13 reflecting the slower pace of recovery in the housing market.
- **Earnings on Investments...** Earnings on Investments relate to the combination of short and intermediate term fixed income investment strategies used for the state's cash balances not needed for day-to-day transactions. Earnings were decreased to reflect the lower interest rates contained within the latest National Economic Outlook, as well as lower expected balances.

Several of the revisions to the General Revenue forecast (Tobacco Taxes, Article V Fees & Transfers, Indian Gaming Revenues, and Highway Safety Licenses & Fees) are the results of earlier conferences. Over the forecast period, the Conference remains cautiously hopeful that the United States (and therefore, Florida) will avoid a second recession. Underlying the forecast is the assumption that a recovery has been underway since the late spring of 2010, but with growth rates that have recently turned more anemic than originally anticipated. While not included in the official forecast, the ongoing turmoil in the Eurozone and its ultimate impact on the credit market and current economic assumptions presents a risk to the forecast.
