Gross Receipts Tax/Communications Services Tax
July 31, 2019
Executive Summary

The Revenue Estimating Conference met on July 31, 2019, to adopt a new forecast for the Gross Receipts Tax and the State Sales Tax on Communications Services. For FY 2019-20, projected collections for the Gross Receipts Tax (derived from the tax on electricity, gas and communications) were increased \$8.78 million and for the State Sales Tax on Communications Services, projections were decreased \$27.69 million from the previous estimates. Compared to the March conference results, the new forecasts for the Gross Receipts Tax were greater for the first six years but with the difference declining, reaching approximately zero in FY 2025-26, and continuing to decline thereafter. The pattern is due to positive and declining differences in the forecasts of taxes on utilities and negative and increasing differences in the forecasts of Communications Services Tax. The changes in the Gross Receipts Tax feed directly into the dollars available for PECO appropriations. The highlights are detailed below.

Gross Receipts Tax on Utilities: Residential price is expected to grow at 0.53% in FY 2019-20. For the forecast going forward, percentage changes in price will be as low as 0.29% in FY 2020-21, but will be within 0.02 percentage points of 0.6% from FY 2021-22 to FY 2028-29. Residential consumption is expected to grow at 0.65% in FY 2019-20, and its growth rate declines to 0.27% by FY 2028-29.

Commercial price and consumption are expected to grow at 0.41% and 1.22% respectively in FY 2019-20. Commercial price growth is forecasted to be 0.22% in the subsequent year and to be between 0.93% and 1.29% for the remainder of the forecast horizon while consumption growth steadily declines from its FY 2019-20 value to 0.78% in FY 2028-29.

Of the three components, industrial electricity has the lowest price and consumption levels. Its price and consumption are respectively growing at -0.91% and 0.44% in FY 2019-20. Price is expected to grow at 0.5% in the subsequent year, and then stay between 0.97% and 1.39% thereafter. Industrial consumption is expected to stay between 0.10% and 0.75%.

These price and consumption forecasts for electricity are in keeping with the March 2019 forecasts, which proved to be relatively accurate in the latter half of the FY 2018-19.

Non-residential consumption of electricity was forecasted using the new forecasts for commercial and industrial consumption and the average ratio of non-residential consumption to the sum of commercial and industrial consumption over the last four years (i.e. 0.55%).

Residential consumption of natural gas is expected to grow at 3.49% in FY 2019-20. The forecast then drops to 1.00% in the next year followed by growth rates between 0.24% and 0.30% thereafter. After the current year, the residential price forecast starts at -0.80% and 0.20% in FY 2020-21 and FY 2021-22 respectively, but generally stays close to 1.00% afterwards. Commercial consumption is expected to increase at a rate of 1.90% in FY 2019-20, 1.30% in FY 2020-21, and stay between 0.44% and 0.87% in the remaining years. Commercial price after the current year is expected to grow at rates of 1.30% and -0.07% in FY 2020-21 and FY 2021-22, and stay between 0.74% and 0.96% thereafter.

State Communications Services Tax, Including Direct-to-Home Satellite Service (CST): The overall forecast relies on generating separate growth rates for the cable, wireless, landline (residential and commercial), miscellaneous services, and direct-to-home satellite tax bases.

The two primary positive drivers of growth in CST have recently been the Cable and Other categories. Despite the drop in subscribers, the cable forecast has general been buoyed by growth in the price of subscriptions. However, in FY 2018-19, Cable experienced -0.03% growth, possibly due to both changes in businesses' practices and falling subscription levels. The forecast balances the typical and the recent behavior of Cable with growth rates starting at 1.12% in FY 2019-20 and steadily increasing to 1.52% by FY 2028-29. The second primary positive driver, Other, includes streaming entertainment and is expected to grow at 6.87% in FY 2019-20 and then gradually taper off to a still strong 3.05% ten years later. Wireless and Landline forecasts counter the positive growth seen in Cable and Other. Wireless has been declining in large part due to unbundling of communication services tied to cellphone plans. The FY 2019-20 decline is expected to be -9.31% and then steadily increase from -5.44% in FY 2020-21 to -3.24% in FY 2028-29. Landline is declining due to its nature as a dated technology and changing behavior. It is expected to fall at rates starting at -5.97% in FY 2019-20 and reaching -2.35% in FY 2028-29. Satellite, or DHSS, experienced strong negative growth in the latest two years, but had strong positive growth in the several years before that. The new forecast steadily declines from 1.77% growth in FY 2019-20 to 1.36% in FY 2028-29.

Finally, the residential exemption is calculated based on the assumption that its level is a percentage of the sum of the levels of Cable, Wireless, Landline and Other. The percentage was equal to at 14.07% in FY 2018-19, decreases by 0.25 percentage points in FY 2019-20 and every three years afterwards.

Gross Receipts CST is derived from two different tax rates plus a portion of direct-to-home satellite collections. First, a tax rate of 2.37% is applied to the cable, wireless, landline and miscellaneous services tax bases. Second, an additional tax rate of 0.15% is applied to the same tax bases, excluding landlines in residential households. The dollars generated by both of these tax rates, plus 18% of total direct-to-home satellite collections, comprise total Gross Receipts CST collections.

Sales CST Collections are generated by applying a tax rate of 4.92% against the cable, wireless, landline and miscellaneous services tax bases, coupled with 44.32% of total direct-to-home satellite collections. The landline tax base is reduced by the residential household telephone exemption for Sales Tax CST.

Direct-to-home satellite service is taxed at an 11.44% rate. The tax revenue is distributed between Gross Receipts CST, Sales CST, and local governments.

Local Communications Service Tax: The local CST forecast applies an average local CST tax rate of 5.0% to the four major bases (cable, wireless, landline and miscellaneous services). Like the CST forecasts for Gross Receipts and Sales, the local forecast is expected to decline because of the reduction in the wireless base.
