Public Schools PK-12 Education Estimating Conference Executive Summary Dec 10, 2010

General Notes:

The Education Estimating Conference for Public School Enrollment forecasts full-time equivalent (FTE) students whose educational instruction is funded through the Florida Education Finance Program (FEFP). There are ten program categories:

- Three for basic education students who are not exceptional education students (101: for K through Grade 3; 102: for Grades 4 through 8; 103: for Grades 9 through 12),
- Three for basic education exceptional educational students by grade grouping (111, 112, 113),
- One for English Language Learners (130),
- Two for exceptional education students who need higher levels of services (254, 255),
 and
- One for students taking career education instruction (300).

The funded educational time for a student may be in a single program category or spread through two or more program categories.

The FEFP is calculated five times throughout the year to arrive at each year's final appropriation. Each calculation ("calc") uses the latest information regarding the number of students that is available:

- (1) First Calculation This calculation is completed immediately after the annual legislative session. Student counts are based on the forecast made for the Legislature.
- (2) Second Calculation This calculation is made upon receipt of the certified tax roll from the Department of Revenue. Student counts are based on the forecast made for the Legislature.
- (3) Third Calculation This calculation is made upon receipt of districts' October survey FTE reported in November and estimated June FTE reported in November.
- (4) Fourth Calculation This calculation is made upon receipt of districts' February FTE and estimated June FTE reported in March.
- (5) Final Calculation This calculation is made upon receipt of districts' June FTE reported in July.

'PK' figures include only pre-school age children with disabilities (ESE) and pre-school age children whose parents are in the Teenage Parent Program. It does not include children participating exclusively in the Voluntary Prekindergarten Program who receive those services through the public school system.

The Public Schools PK-12 Education Estimating Conference met on Dec 10, 2010, to review forecasts of FTE student enrollment for the 2011-12 through 2013-14 fiscal years. While growth continues throughout the new forecast, the incremental increase from year to year has been reduced.

Key Data Source

FTE enrollment for 2010 --- The 3rd calc FTE replaced the FTE used for the General Appropriations Act. The 3rd calc FTE is 6,284.28 lower than the FTE used for the General Appropriations. The appropriated FTE included a forecast of 6,300 students entering from Haiti as a result of the January 2010 earthquake. This influx of students did not occur and almost all of the students who entered Florida public schools from Haiti from mid-January, 2010 through the end of the 2009-10 school year had left the system by the October survey.

Key Assumptions

<u>The Florida Virtual School</u> --- The annual growth rate is forecasted to be 20 percent throughout the forecast period. The July forecast assumed a rate of 25 percent annually.

<u>Continuation of recent historical patterns</u> --- The most recent growth patterns are expected to continue. The July forecast had the same assumption.

Trends

- New charter schools will continue to attract students to public education.
- Kindergarten enrollment is expected to increase due to larger birth cohorts reaching kindergarten age.
- The 2012-13 school year enrollment is affected by the graduation in 2011-12 of an unusually small grade twelve cohort of students.
- The lower non-promotion rates in 2009-10 means that some students will graduate sooner than expected under the previous non-promotion rates. This trend reduces the enrollment growth rates for the forecast period. [See "NP" Row Below]
