Revenue Estimating Conference Slot Machine Revenues October 5, 2007 Executive Summary

The Revenue Estimating Conference meeting on Slot Machine revenues adopted revised estimates for tax revenues from slot machine operations for fiscal years 2007-08 through 2010-11. The estimates of transfers to the Educational Enhancement Trust Fund were increased as follows: in 2007-08 from \$113.5 million to \$123.1 million, in 2008-09 from \$123.6 million to \$133.3 million, in 2009-10 from \$151.6 million to \$157.8 million, and for 2010-11 from \$172.9 million to \$179.1 million.

The forecast reflects updated tax collections data and information concerning the number of machines in the currently operating facilities. Collections have exceeded estimate over the first 3 months of the fiscal year by 8.1%, and that trend is expected to continue. For the number of machines, Gulfstream had an unanticipated reduction by 80, but otherwise the forecast remains unchanged from the prior conference.
