

**Revenue Estimating Conference**  
**Slot Machine Revenues**  
**February 5, 2014**  
**Executive Summary**

The Revenue Estimating Conference reviewed slot machine revenues on February 5, 2014, and increased projections from the October 2013 conference. The details of the forecast and changes are shown in the following table.

Slot machine tax revenues were \$1.4 million above estimate for November through January. All of the facilities, except for Gulfstream, have seen growth in income per machine compared to the same period last fiscal year. Reflecting the strong activity data seen fiscal year to date, the new forecast increases the tax revenue growth rate for Fiscal Year 2013-14. Growth rates in subsequent fiscal years remain very similar to those in the October forecast.

The forecast for the Dania facility was changed to reflect an earlier projected opening date of April 1, 2014, rather than June 1, 2014. It is expected to begin operations with 500 machines and an income per machine that is consistent with neighboring facilities. It is also expected to have a negative impact on the three facilities in closest proximity to it (Gulfstream, Mardi Gras, and Calder), resulting in lower Fiscal Year 2014-15 revenues for those facilities.

The October 2013 and February 2014 forecasts both reflect the change from weekly to monthly collections that became effective July 1, 2012. The Fiscal Year 2012-13 revenue of \$142.2 million is based on actual collections received during Fiscal Year 2012-13. Because the state switched from weekly to monthly collections at the end of Fiscal Year 2011-12, the July 2013 collections are made up of only one week of June 2013 revenue. This is expected to have a one time impact lowering the Fiscal Year 2012-13 revenues by approximately three weeks of collections. Likewise, the Fiscal Year 2013-14 revenue estimate is significantly higher than the Fiscal Year 2012-13 estimate, partly due to this change in collection frequency, as it represents a full year of monthly collections.

**NOTE:** This estimate is based on the operation of slot machines in eight pari-mutuel facilities located in Miami-Dade and Broward counties. If additional slot machine operations are authorized by legislative or administrative actions in other locations, revenues from slot machine operations will likely increase.

This is expected to have a one time impact lowering the FY2012-13 revenues by approximately three weeks of collections. The income per machine per day is based on actual DBPR activity data for FY2012-13.
